West's National Reporter System divides the 50 states and the District of Columbia into seven regions: Atlantic, North Eastern, North Western, Pacific, South Eastern, South Western, and Southern. The National Reporter System covers the appellate courts of all the states and the District of Columbia. The federal reporters published by West are also part of the National Reporter System.
